



## Cleo Carlisle Huff

October 28, 1923 - May 19, 2007

Mrs. Cleo Carlisle Huff, age 83, passed away on Saturday evening, May 19, 2007 at her home in Del Rio surrounded by her loving family and friends. She had suffered with Alzheimer's disease for the past five years and three weeks ago sustained a debilitating stroke.

Cleo was born on October 28, 1923 in Del Rio to parents, Leslie D. and Scottie Clark Carlisle who preceded her in death. She was a graduate of Cocke County High School and was married in 1941 to Frank Huff, Jr. who preceded her in death in 1981. A son-in-law, Johnny Glen Ellison and two brothers-in-law Fletcher Ford and Floyd A. Branam, also preceded her in death.

Cleo Huff was a well known and much loved member of the Del Rio Community having worked with the Cocke County Board of Education in the Del Rio School system for over twenty years, retiring in 1990. Cleo loved tending her large garden every year, doing yard work and spending time with her family and friends. She was of the Baptist faith and was a long time member of Del Rio Baptist Church.
